- Coaching supervision is always required in the gym
- Coach permission is required to:
 - enter gym
 - go on equipment
 - try new skills
 - perform aerial inversions or flips
 - leave the gym
- Understand the risk of the activity
- Be prepared to participate:
 - be healthy and not tired
 - wear proper clothing and footwear
 - have long hair tied back
 - always warm up
- Stop unsafe and careless acts which could cause injury by:
 - listening
 - following instructions
 - controlling your actions
- Participate cooperatively within the limits set by the coach
- Double check equipment
- Master basic skills before attempting more advanced skills
- Keep your body under control
- Follow equipment and safety procedures
- Be alert and safety conscious
 - watch where you are going
 - walk don't run
 - watch for obstacles or uneven surfaces
- Respect others' performances - no distractions
- Parents and spectators must stay in their designated area
